WE HIGHLY RECOMMEND THAT YOU STORE YOUR PRINTED ITEMS IN A SECURE LOCATION AND TREAT IT AS YOU WOULD ANY VALUABLE!

You are responsible for distributing your (6) printed tokens to each person in your party. Unauthorized duplication of these tokens will prevent your admittance into the event. Each item will be scanned upon entrance. Once scanned, the individual barcode will be recorded in our system and rendered "complete" which means that **ONLY** the first 6 scans are allowed into the Rock USA gates. Illegal copies will not be accepted.

TIP: IF YOU CHOOSE TO CHECK IN EARLY ON WEDNESDAY, JULY 11 OR THURSDAY, JULY 12 PLEASE BE AWARE THAT ONCE YOU LEAVE THE GROUNDS YOU WILL BE BACK IN THE LINES COMING IN. THESE LINES ARE VERY LONG ON THURSDAY AND FRIDAY. WE RECOMMEND THAT ONCE YOU CHECK-IN, YOU STAY ON SITE.

AVOID LONG LINES AT ROCK USA! RENEW YOUR SAME CAMPSITE FOR 2019 ONLINE FROM JUNE 28 - JULY 14! YOU WILL RECEIVE AN ADDITIONAL EMAIL TO RENEW YOUR CAMPSITES. LOGIN TO YOUR ACCOUNT USING THE EMAIL ADDRESS AND PASSWORD YOU CREATED.

YOU MAY ALSO ORDER THEM AT THE FESTIVAL FROM JULY 12 THROUGH JULY 14 AT THE VIP SALES TENT AND YOU WILL STILL BE GUARANTEED THE SAME CAMPSITE FOR 2019. THE VIP SALES TENT IS LOCATED TO THE LEFT OF THE STAGE.

PHONE RENEWAL ORDERS ARE ONLY TAKEN PRIOR TO THE FESTIVAL.

THE FOLLOWING IS A LIST OF ROCK USA 2018
CAMPING RULES AND INFORMATION...
PLEASE READ CAREFULLY AS
THESE RULES WILL BE STRICTLY ENFORCED!!

1. IF YOU HAVE PURCHASED AN ELECTRICAL CAMPSITE:

Your site will have - 1-RV 100 volt 30 amp connection (TT-30) – If connecting to 30 amp, bring a 50 ft - 10 gage cord. Power will be brought to the edge of the campsite and will be your responsibility to provide appropriate connection. Rock USA is not responsible for any power difficulties “after” the connection point. Event assumes no responsibility including electric damage.

Ticket holder assumes complete risk and responsibility for any and all loss, theft, damage or injury to person or property as the event assumes no responsibility.

ROCK USA TIPS TO HELP MAKE YOUR ELECTRICAL CAMPING A PLEASANT EXPERIENCE:

- Bring correct extension cords! In previous years Inspectors have cut cords that were incorrect
- Remember you have 30 amps
 - An average air conditioner for a camper is 15 amps, which is half your power. Running a hair dryer and a microwave at the same time will exceed capacity. A toaster and hair dryer may exceed 20 amps. Two hair dryers plugged into the same 20-amp outlet WILL exceed capacity!

2. CAMPFIRES:

State statutes and local ordinances concerning open fires apply. **Every fire must be contained. This means on legs, above ground with covers on top and bottom with a screen around the center. Fires must be extinguished by 2:30am.** Citations will be issued to violators. Only firewood from a 50 mile radius allowed. **Campfires must be on site – NOT ON ROADS.**

3. CHECK-IN / TOKENS:

Campers may arrive on Thursday, July 12, 7:00am and must vacate the grounds by Sunday, July 16, 10:00am. Check-in times are 7:00am to 10:00pm Thursday - Saturday. **NO CHECK IN AFTER 10PM.**

As you enter please go to the Camper Check-In (Gate 3) to pick up your window sticker and exchange your tokens for wristbands. Window sticker must be attached to your vehicle’s windshield at all times!!

WINDOW STICKERS ARE NON-TRANSFERABLE BETWEEN VEHICLES!! YOU MAY NOT SELL OR GIVE TOKENS TO ANYONE NOT ON YOUR CAMPSITE! Anyone trying to redeem a token that is not on your site will result in the ejection of everyone on your site and loss of tickets!!

NOTE: LOST WRISTBANDS WILL NOT BE REPLACED.

EVERY CAMPER MUST HAVE a 3-Day Rock USA Ticket and exchange it for a wristband at the main entrance. Single Day ticket holders will not be allowed access to camping. Each campsite will receive 6 tokens per campsite. (Limit of 6 due to county ordinance. Extra camping tokens are not available for purchase).

- CAMPERS ARE RESPONSIBLE FOR PARKING THEIR OWN UNITS ON THEIR SITE.

4. SHOWERS:

Showers are available from approximately 7:00am to 5:00pm daily at a nominal charge. Operating times are subject to change. Showers are located across from campers check-in.

5. VEHICLES PER SITE:

One steering wheel per site is included in your camping fee. ALL ADDITIONAL VEHICLES, INCLUDING MOTORCYCLES, WILL BE CHARGED **\$50.00** for the festival. Extra vehicles may be placed on your site provided they fit completely on your site. If not, extra vehicles may park in camping overflow parking. (Either location is the same cost). You may purchase extra parking passes at campers check-in or online, rockusaoshkosh.com. Window stickers must be attached to your vehicle's windshield at all times and are **NON-TRANSFERABLE BETWEEN VEHICLES**.

6. BEHAVIOR:

Excessive rowdiness and underage drinking will not be tolerated. Disruptive or disorderly behavior will result in arrest and/or ejection from the campgrounds and festival site. All state and local traffic ordinances will be enforced.

NO ONE MAY OPERATE ANY MOTOR VEHICLE WHILE INTOXICATED!!! OPERATION OF A MOTOR VEHICLE WHILE INTOXICATED WILL RESULT IN ARREST AND/OR EJECTION.

7. GENERATORS:

All generators must have a good muffler system and be turned off by 2:30am. They can be turned back on at 8:30am. **THIS APPLIES TO ALL GENERATORS.** If you have a CPAP or other medical device that requires round the clock use, it should be battery operated or you must purchase an Electrical Campsite.

8. CLEAN UP:

Please leave your campsite clean. Campers can place their trash at curbside for daily pickup. Campsites will be inspected following the festival. Those sites not cleaned up will be charged a \$50.00 clean up fee.

9. SANITARY:

Pit Stop Portables is on site during the festival offering pumping and fresh water service for your RV or camper. Average cost for pumping is \$25 depending on the size of your camping unit. To arrange pumping or fresh water, stop and see them at the showers. Camper pumping and fresh water delivery services start approx. 1PM daily until dark. AS STATED IN WINNEBAGO COUNTY HEALTH CODE, NO DUMPING OF GREY WATER is permitted under any circumstances. **VIOLATORS WILL BE EJECTED. CITATIONS WILL BE ISSUED. STRICTLY ENFORCED!**

10. SECURITY:

Security may be reached 24 hours a day at 920-235-2340. Have your site number available.

11. SOLICITATION:

No advertising or solicitation of any kind! This includes signs, banners & flags, with the exception of Rock USA sponsors (No offensive signs or banners). No camper will be permitted to engage in any private business. No sale of food, beverages, merchandise or any other goods/services.

12. TOWING:

One Stop Towing Exclusive & Official Towing Service - Telephone # is 920-233-6274

1. One Stop Towing is the official contracted towing service for Country USA and Rock USA.
2. We will allow our patrons to select the towing vendor of their choice.
3. Independent towing services/equipment will not be allowed an "onsite" presence during the events but will be allowed access.
4. Independent towing services will be required to enter at Gate #1 Ripple Road and check in at the One Stop Event Towing Office.
 - a. If hiring a towing vendor other than the One Stop Towing, the patron will be charged an Event Towing Surcharge in the amount of \$40 in addition to the towing charge.

- **NO PLATFORMS / RAISED STAGES / DANCE FLOORS ALLOWED**
- **NO LARGE SOUND SYSTEMS OR DJ SET-UPS ALLOWED (small speakers only)**
- **No motorized lawnmowers**
- **No hay bales, straw bales, wood chips, wood pallets, any wood with nails or any other ground cover allowed in the campgrounds**
- **DRONES ARE NOT ALLOWED ANYWHERE IN CAMPGROUND OR FESTIVAL PROPERTY**
- **CAMPSITES ARE LIMITED TO 6 PEOPLE PER SITE**
- **No Ticket or Camping refunds or exchanges**
- **24 HR Security is provided by Rock USA for your safety. Call 920-235-2340**
- **There must be someone at least 21 years old on each site that is held responsible for minors**
- **Patrons assume complete risk and responsibility for any and all loss, theft, damage or injury to person and/or personal property including electric damage, as event assumes no responsibility. No liability is assumed by event, owners, managers, promoters, sponsors or others associated with event**
- **Concealed and/or carried with a permit WEAPONS ARE PROHIBITED and will be confiscated**
- **Knives, weapons, contraband, or other items representing knives, weapons or contraband strictly prohibited on our site and will be confiscated**
- **Anyone consuming alcohol under 21 will be prosecuted and subject to ejection by management**
- **FESTIVAL MANAGEMENT RESERVES THE RIGHT TO EJECT ANYONE AT ANY TIME AT ITS SOLE DISCRETION. NO REFUNDS WILL BE ISSUED FOR ANY EJECTION**
- **FOOD AND BEVERAGE CANNOT BE CARRIED INTO THE CONCERT GROUNDS**
- **Campers are not allowed on top of their camping units.**
- **No kegs or glass beverage containers allowed**
- **No pets**
- **No golf carts, boats, power scooters (ADA scooters allowed), dirt bikes, or ATVs are allowed on site. No cruising on motorcycles or in vehicles within the campground or parking lots.**
- **Any person or property on festival grounds is subject to search at any time, including entry gates, per management request.**
- **Campsite location may be subject to change due to unforeseen circumstances. Locations are NOT GUARANTEED.**

Rock USA has grown into one of the nation's largest festivals and has caused us to focus on dangerous activities that may cause accidents and harm. We want your festival experience to be both safe and memorable! Rock USA management and the Winnebago County Sheriff's Office have now found it necessary to issue the following rules to help ensure your safety:

- A. Cruising the campgrounds or driving from site to site will not be permitted. This includes all vehicles. **STRICTLY ENFORCED!** Vehicles will only be permitted to operate on the site for the purpose of leaving or returning to a campsite from an off-site destination.
- B. All State traffic statutes relating to the safe operation of motor vehicles will be **STRICTLY ENFORCED**, including driving while intoxicated, reckless driving, and speeding. Passengers will not be permitted to ride in the cargo bed of trucks, sit or stand on rails or tailgates of trucks, or ride on the outside of any motor vehicle. **ALL VIOLATIONS OF STATE TRAFFIC STATUTES WILL BE STRICTLY ENFORCED!**
- C. **VIOLATIONS OF FESTIVAL RULES AND/OR STATE TRAFFIC STATUTES MAY RESULT IN ANY OR ALL OF THE FOLLOWING:**
 - Citations and/or arrest by a law enforcement officer.
 - Temporary or permanent ejections of the responsible person and or vehicle from the campsite and/or festival site.
- D. **Campers are not allowed to be on the roof of their motor home, camping unit or vehicle at any time. This will result in immediate ejection from the campgrounds.**
